On this date, we, the Board of Trustees of the Ysleta Independent School District, hereby levies or sets the tax rate on \$100 valuation for the District for the 2022-2023 tax year at a total tax rate of $\frac{1.4589}{1.4589}$ , to be assessed and collected by the duly specified assessor and collector as follows:
\$ <u>0.9839</u> for the purpose of maintenance and operations, and
\$ <u>0.4750</u> for the purpose of payment of principal and interest on debts.
Such taxes are to be assessed and collected by the tax officials designated by the District.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.
