

## Order to Set Tax Rate

Date: August 23, 2023

On this date, we, the Board of Trustees of the Ysleta Independent School District, hereby levies or sets the tax rate on \$100 valuation for the District for the 2023-2024 tax year at a total tax rate of \$ 1.2813, to be assessed and collected by the duly specified assessor and collector as follows:

\$ 0.8263 for the purpose of maintenance and operations, and

\$ 0.4550 for the purpose of payment of principal and interest on debts.

Such taxes are to be assessed and collected by the tax officials designated by the District.


OPERATIONS TAX RATE	\$ 0.82630	PER \$100 VALUATION

TOTAL TAX RATE	\$ 1.28130	PER \$100 VALUATION


It was then duly moved and seconded that said Order be passed; and, after due discussion, said motion, carrying with it the passage of said Order, prevailed and carried by the following vote:
