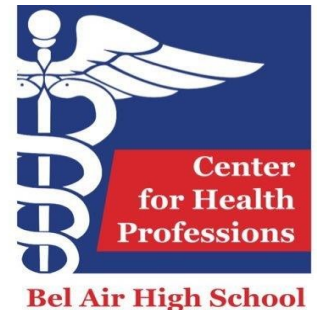

Packet of Interest Requirements:

Three 300 word typed essays (A.P.A. Cover Sheet Required - Font size 12):

Essay 1: The BSN program will require courses to be completed during each summer starting in the Summer of 2020, describe what challenges you will face and how you plan to prepare and overcome these challenges.

Essay 2: Tell us about a time you stepped into a leadership role. This does not have to be an official role. How did you take charge of the situation? What made you take a lead? What was the outcome of this role; did it open new opportunities for you?

Essay 3: Talk about a time when you felt overwhelmed with your school work. What did you do to complete your assignments and prepare for future situations?

(Note: Hand written essays will not be accepted)

2. Academic History will be evaluated for acceptance into the program – Math and Science, attendance, and discipline
 Students must maintain a 3.0 or higher GPA as a prerequisite for acceptance into the BSN program at Texas Tech University.

Students in 11th and 12th grade students may not apply for the BSN program due to the program requirements.

NEW STUDENTS - 9TH/10TH

Students who are **enrolled in another high school** or students who are out of state, must be accepted into the Center for Health Professions Program to apply for the BSN program. Students applying for the program must submit all of the above requirements except for 7th and 8th grade STAAR Scores. Students need to submit 9th and/or 10th grade E.O.C. results (i.e. Algebra I, Biology, English I, English II). Finally, **new students need to enroll in Principles of Health Science and/or Health Science to establish an academic foundation and must take the TSI exam with qualifying scores for the BSN program.**

CURRICULUM CHOICES

Bel Air High School Center for Health Profession students will carry a dual enrollment to ensure students meet the state requirements for high school graduation and the BSN course requirements for an associate's degree from El Paso Community College.

**Reminder, the BSN program will limit the electives/extra-curricular classes you can take.
 Students will be completing 66 college courses in Dual Credit / OnRamps.**

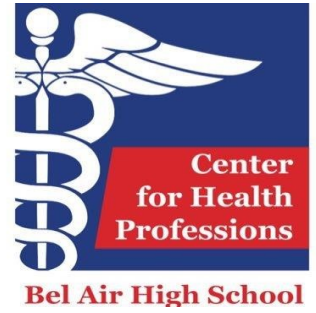
NOTE: All students entering the BSN program must take/pass the TSI exam to be eligible to enroll in EPCC dual credit courses

STUDENT / PARENT COMMITMENT 2021-2022

We, the student and parent, understand that students who plan to attend Bel Air High School's Center for Health Professions must meet the minimum standards for acceptance. We recognize that attendance at Bel Air High School Center for Health Professions is a privilege not a right. Admission to the Center for Health Professions is competitive and admission is based on the student's ability to meet the set academic, attendance, behavior and citizenship criteria. Students are held to a higher standard than required by non-magnet schools. With this acknowledgment, we understand that the following standards and requirements must be complied with in order to be considered for enrollment and continued enrollment at the Center for Health Professions. Failure to adhere to the following guidelines will lead to the student being placed on probation and /or separated from the program.

As a future student, we understand and agree to:

1. Prioritize my schedule and put first things first by not over-extending myself and making commitments with other programs which can affect my status in the Center for Health Professions.
2. *****Attend all mandatory H.P. meetings, if required, Wednesday No Excuse Zone (NEZ), Saturday T.S.I. tutoring.**
3. Maintain positive behavior without any discipline referrals. (NOTE: Students placed at Cesar Chavez Academy, those who are involved with controlled substances or alcohol, fight, bully, break any rule(s) at a job site, inappropriate behavior on social media, and or other behavior violating YISD Code of Conduct will be considered a severe violation and will be immediately separated from the Center for Health Professions Program).
4. **Maintain exemplary attendance; in class attendance at 90% of the time.**
5. **Maintain an 85 cumulative G.P.A. yearly**
6. Enroll and successfully complete **all required BSN dual credit courses.**
7. Enroll in Algebra II Sophomore year. (NOTE: Students might need to **double up on math courses** their Sophomore year)
8. Take all required exams for certification.
9. **Provide my own transportation as needed** to fulfill all class requirements. (NOTE: Transportation is required for many of our programs, failure to have steady transportation at the start of the year might lead to the removal from the program during any part of the semester).
10. Follow District and the Center for Health Profession dress code, including but not limited to beards, hair length/color/style, grooming, fingernail length, facial piercings, gauges, dress and footwear.
11. Abide by all YISD discipline policies to include not being involved with gangs or gang activities, including exhibiting gang graffiti, gang clothing or gang insignias. (Please see #2)
12. Demonstrate the appropriate social manners while interacting with different health care professionals and adhere to all rules and regulations established at school
13. Return all required paperwork the following day.
14. Abide by ALL HIPAA regulations and not jeopardize BAHS clinical teacher's certification and or credentials by violations of HIPAA, YISD regulations, and or the medical center/job site rules.
15. Pass all E.O.C. exams on the first proctoring.
16. Have my Titters and all paperwork completed as of the first day of the school year
17. Not being part of a tie-breaker if I am on academic probation for the semester or school year.
18. I must be enrolled in a H.P. course to be a member of the Center for Health Professions. Once in a program, I can't move to another H.P. pathway during the school year

We understand that because of the health/medical focus of the Center for Health Professions, students may work directly with blood and body fluids, and they will study sexually transmitted diseases. We understand that students who attend the Center for Health Professions are involved in activities at school and while at health care facilities such as hospitals that may require handling of highly confidential patient information, assisting with patient care and transporting patients in beds or wheel chairs. Students involved in such activities will be required to abide by the standards set at such facilities. Health care facilities may have rigid requirements concerning the aforementioned. Finally, ***schedules are subject to change up until the third week of school due to the balancing of class loads and agreements with outside institutions which support our various internship programs.***
