General Information

This type offense is a Class A Misdemeanor unless the actor's intent is to defraud, in which event the offense is a felony of the third degree. (PENAL CODE, Chapter 37)

In addition to the penalty provided by Section 37.10 (Penal Code), a person who knowingly falsifies is subject to the greater of:

- 1.The maximum tuition the district may charge, or
  - 2.The amount the district has budgeted for each student,
