

Order to Set Tax Rate

Date: September 17, 2020

On this date, we, the Board of Trustees of the Ysleta Independent School District, hereby levies or sets the tax rate on \$100 valuation for the District for the 2020-2021 tax year at a total tax rate of \$ 1.4466, to be assessed and collected by the duly specified assessor and collector as follows:

\$ 1.0541 for the purpose of maintenance and operations, and

\$ 0.3925 for the purpose of payment of principal and interest on debts.

Such taxes are to be assessed and collected by the tax officials designated by the District.


OPERATIONS TAX RATE	\$ 1.054100 PER \$100 VALUATION
DEBT SERVICE TAX RATE	<u>.392500</u> PER \$100 VALUATION
TOTAL TAX RATE	\$ 1.446600 PER \$100 VALUATION
