

Order to Set Tax Rate

Date: August 25, 2021

On this date, we, the Board of Trustees of the Ysleta Independent School District, hereby levies or sets the tax rate on \$100 valuation for the District for the 2021-2022 tax year at a total tax rate of \$ 1.5270, to be assessed and collected by the duly specified assessor and collector as follows:

\$ 1.0320 for the purpose of maintenance and operations, and

\$ 0.4950 for the purpose of payment of principal and interest on debts.

Such taxes are to be assessed and collected by the tax officials designated by the District.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

THE TAX RATE WILL EFFECTIVELY BE RAISED BY 3.69 PERCENT BUT WILL REDUCE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$22.10 ANNUALLY.

THE TAX RATE WILL EFFECTIVELY BE RAISED BY 3.69 PERCENT BUT WILL DECREASE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$22.10.
